

CONDITIONS OF ENTRY TO FREMANTLE PORTS

Fremantle Ports is a Port Operator under the Maritime Transport and Offshore Facilities Security Act 2003. Unless exempt under Federal, State or Territory Law, all persons seeking access through Fremantle Ports' gates into operational areas, must acknowledge and agree to the following conditions.

CONDITIONS OF ENTRY

- Persons accessing Fremantle Ports must hold and be in possession of a valid MSIC with FP Access or be continually escorted and monitored by the holder of a valid MSIC with FP Access.
- Persons accessing Fremantle Ports must have undertaken the relevant Fremantle Ports' security/safety awareness induction or be continually escorted and monitored by a person who has undertaken the Fremantle Ports' security/safety awareness induction.
- FP Access is granted for official Port business only. Any access not authorized by Fremantle Ports may result in future access being restricted.
- An FP Access cardholder is not permitted to transfer their card to any other person. It is the cardholders obligation to ensure the card is secured at all times.
- An FP Access cardholder must declare all passengers in their vehicle when entering the Port.
- Any suspicious activities must be reported to the Security Control Room on (08) 9430 3315.
- Access to Cargo (Goods) is only permitted with Customs and/or Quarantine authorization.
- The MSIC with FP Access must:
 - be attached to your outer clothing
 - o be worn above waist height
 - o be on the front or side of the body
 - o be worn wholly or be clearly visible, and
 - not be altered or defaced.
- All persons must wear appropriate personal protection equipment.
- All vehicles must display an orange flashing light in operational areas, stay clear of the cargo operational areas, adhere to speed limits and keep clear of the quay crane access ways.
- All contractors and union officials must give prior notification of an intended visit and must request access from the relevant employer.
- All visitors must be placed on the 'Port Access Escort List' and be accompanied by an MSIC with FP Access holder. The visitor must be within 30 meters of the MSIC and FP Access holder. The maximum number of persons to be escorted by a holder of a valid MSIC and FPA Access card is 4 (four) persons. Each will only be permitted one approved application every 12 months.
- All pedestrians must remain within the designated pedestrian walkways.
- All taxis are to comply with the directions of the Security Control Room.
- Unauthorized entry by tailgating another vehicle through a security gate without stopping and being approved for entry is an offence. Offenders may be immediately ordered from the area and denied future access.

In the event of an emergency, all personnel are to report to the designated mustering points and follow the instructions of the terminal operator or designated incident controller.

MSIC and/or FP ACCESS CARD ISSUED BY FREMANTLE PORTS

THIS CARD DOES NOT ALLOW FOR ACCESS TO DP WORLD/PATRICKS.

This is an electronic card which needs to be presented at a reader at your approved Fremantle Ports Landside Restricted Zones to gain access.

To use the card as an access card at an FP electronic gate, the holder must swipe the card on the reader and present their face to the CCTV camera with the MSIC alongside their face.

- In the event that the holder of this card intends to escort other persons to Fremantle Ports, the holder must submit an application providing minimum 24 hours' notice, including details such as date of birth and current residential address, of all persons being escorted. The form can be found at <u>MSIC / Port Access -</u> <u>Fremantle Ports</u>. Additionally:
 - Escorted person/s will present suitable photographic identification (e.g., driver's license) on arrival at the gate; and
 - Escorting will only be permitted <u>once</u> per person if an MSIC application has not been made.
- A lost or stolen MSIC or FP Access card must be immediately reported to the MSIC Service Centre on (8) 9430 3322 or <u>ssc@fremantleports.com.au</u>

In the event of any breach of use of this MSIC and/or FP Access card, Fremantle Ports may, at its sole discretion cancel the access rights granted on this card.

MSIC (with FP ACCESS) ISSUED BY FREMANTLE PORTS

In accordance with the Maritime Transport and Offshore Facilities Security Regulations Act 2003 and Fremantle Ports Access requirements:

- □ This card is your MSIC and is recognized Australia wide.
- D This card is also your Access Card to Fremantle Ports <u>ONLY</u>.
- □ This card is a combined card. The face contains information relating to your MSIC and the reverse contains information relating to Fremantle Ports Access.
- □ This card may be used to access regional ports in Western Australia upon satisfactory completion of the destination ports' access requirements. Contact the regional port to obtain further information.

Upon collection of your FPA MSIC or FP Access card, you declare the following:

- **1.** I confirm that I was the actual person that viewed (either) the online Port User or the Operational Security/Safety Induction.
- **2.** I understand that should it be found this confirmation has been falsely made, my future access to Fremantle Ports may be denied.
- **3.** I confirm that I have read and understood the conditions of entry to Fremantle Ports and agree to comply with these conditions during the life of the MSIC and/or FP Access Card.
- **4.** I understand that failure to abide by the above conditions is likely to result in the revocation of wharf access privileges.
- **5.** I acknowledge that access to the wharf is granted on the basis that I will not access cargo goods under Customs control without making prior arrangements with the Australian Customs Service or Australian Quarantine and Inspection Service to be accompanied.
- **6.** I acknowledge that I am aware that moving, altering or interfering with goods subject to the control of Customs is an offence under Section 33 of the Customs Act 1901.
- **7.** I acknowledge that only I am permitted to use my card and I am responsible for ensuring it is secured at all times.
- **8.** I acknowledge all visitors I escort must be placed on the 'Port Access Escort List' and be accompanied by myself. The visitor must be within 30 meters. The maximum number of persons to be escorted is 4 (four) persons. Each will only be permitted one approved application every 12 months
